EXPLANATORY NOTE

This Amendment No. 2 to the Registration Statement on Form 8-A (File No. 001-42813) originally filed on August 22, 2025, and amended on September 11, 2025, notes the planned change of the name of the Registrant from Yukon New Parent, Inc. to Mount Logan Capital Inc. following the consummation of the all-stock merger between 180 Degree Capital Corp. and Mount Logan Capital Inc. and corrects the name of the exchange on which the shares of the Registrant will be registered in Item 2.

Item 1. Description of Registrant's Securities to be Registered.

The securities to be registered hereby of Yukon New Parent, Inc. (to be renamed "Mount Logan Capital Inc." following the consummation of the all-stock merger between 180 Degree Capital Corp. and Mount Logan Capital Inc.) (the "Registrant") are shares of common stock, par value \$0.0001 per share. The description of the common stock set forth under the heading "Description of New Mount Logan Share Capital" in the prospectus forming part of the Registrant's Registration Statement on Form S-4 (File No. 333-286043), originally filed with the Securities and Exchange Commission on March 24, 2025, as thereafter amended and supplemented from time to time (the "Registration Statement") is incorporated by reference herein. Any form of prospectus or prospectus supplement to the Registration Statement that includes such descriptions and that is subsequently filed is hereby also incorporated by reference herein.
